

## **Privacy Policy**

Protecting your private information is our priority. ### **Collection of your Personal Information**

Third DCA HS may collect personally identifiable information, such as your name. If you purchase Third DCA HS's products and services, we collect billing and credit card information. This information is used to complete the purchase transaction. Third DCA HS may also collect anonymous demographic information, which is not unique to you, such as your gender. We may gather additional personal or non-personal information in the future.

Information about your computer hardware and software may be automatically collected by Third DCA HS.
